Course Goals:

English I is the study of world literature and informational texts, writing, language, speaking, and listening skills. Emphasis is placed on analysis, research, grammar, vocabulary, and discussion skills. English I is the foundation for all other courses in the language arts curriculum.

Honors English I encompasses English I content and skills and is the enriched study of world literature and informational texts, writing, language, speaking and listening skills. Emphasis is placed on advanced analysis, research, grammar, vocabulary, and discussion skills. Honors English I is the foundation for all other courses in the Language Arts curriculum including AP/IB courses and is designed for self-motivated learners.
