Application:

- This application will ***only*** be considered if it is completed in its entirety and received by the enrollment center at **7060 Coffman Rd on or before 4:00 p.m. on the 1st business day of May.**
- Parent/Guardian should complete a separate application for each student.
- Schools with available capacity are listed on the next page. Applications for schools with no capacity will be denied.
- For **High School *only***, approved transfers remain in effect through grade 12 at the requested school. A new application must be submitted ***each*** year for **Elementary and Middle school.**

Transportation:

- Shall be the responsibility of the parent/guardian, unless the student can be picked up and dropped off at a stop on a regular transportation route for the approved school. This option is only available with approval from the Transportation Department.

OHSAA:

- Amendments to the Ohio High School Athletic Association Bylaws impose a penalty on high school athletes who transfer between schools within the same district once they have established eligibility. Any current freshman, sophomore, or junior who asks for and is granted a transfer shall be eligible, insofar as transfer is concerned, for **ONLY** the first 50% of maximum allowable regular season contests in those sports in which the student participated during the 12 months immediately preceding this transfer. After the first 50% of the maximum allowable regular season contests have been completed, the student shall then become **INELIGIBLE** for the remainder of the regular season contests. Furthermore, the student shall also remain ineligible to participate in the OHSAA sponsored tournament(s) in those respective sports until the one-year anniversary of the student's date of enrollment. There is no penalty for incoming freshmen since they have not established their eligibility until they begin class or participate in a sport. (OHSAA Bylaws 4-7-2).

Application Decision:

- Shall be made on or before **June 15.**
- Parents will be notified of their status via e-mail.
